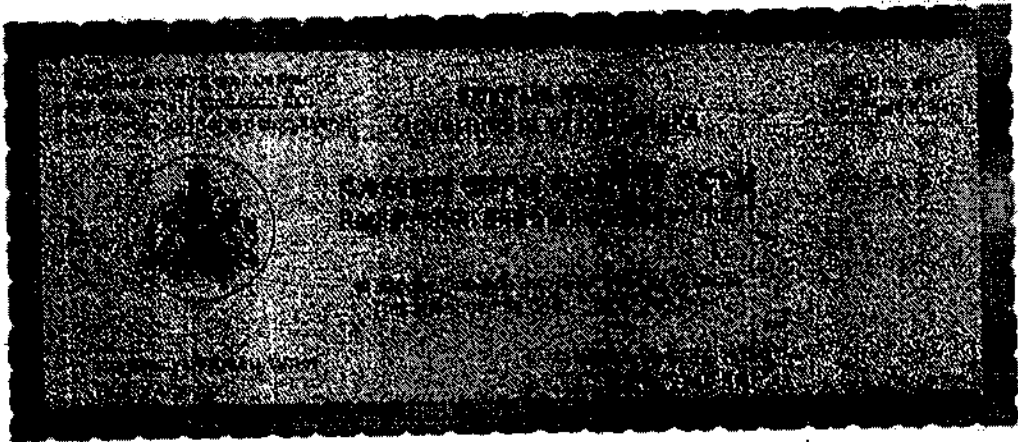

2. At the original deed of 21.11.2009

Whereas, the Trust deed pertaining to "Arka Educational and Cultural Trust" containing the objects of the Trust, Trust Fund, the Rights and duties and power of Trustees or Board of Trustees and the Account of Trust etc., has been registered in the Office of Sub-Registrar, Hasavanagudi, Bangalore as Document No.00138/2009-10 in Book-IV and stored under C.D.No.123 on 21.11.2009.

Whereas, after coming into force of "Arka Educational and Cultural Trust" considerable progress has been achieved by the Trust headed by the present four trustees including the Author of the Trust. However, the above said Trust has decided to add some of the objects with respect to Schools and Colleges of various Syllabus of subjects recognized/ affiliated by the Central Government and State Governments and willing to extend the same through out India. Some of the objects shall have to be included in the Principal/Original Trust Deed dated: 21.11.2009 by way of amendment. In this background, the Board of Trustees in their Board meeting held on 01.06.2010 have decided to add some of the objects by amending relevant clause in the original Trust Deed dated: 21.11.2009, to suit the present requirement of Trust and accordingly authorized Sri. R. Chennaj Jain, the Author of the Trust and now Managing Trustee of the Trust and other three Trustees of the Trust mentioned above to execute this Deed of Amendment of Trust.

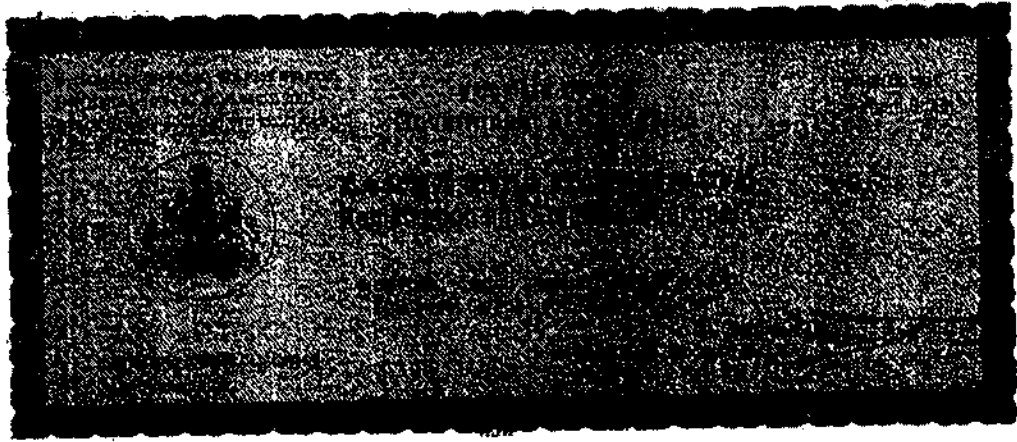
